For each category and Best Of Show plus the David Quick Memorial for Best Young Modeler

- "Camelot to Woodstock: Those Groovy 60s" from 1 Jan 60 to 31 Dec 69; any genre, any scale.
- ◆ The President's Award will go the Best Model of club president's choice that deems worthy of a President's Award.
- "Wings of the Mighty Eighth: Harold "Buck" Rigg Memorial Award" is anything related to 8th Air Force from WWII to present from aircraft to missiles.
- "Bud Lindemann Car and Track Award" is for any car manufactured between 1964 to 1979 which covers the beginning of his sportscast in "Autoscope" to his last in "Car and Track".
- "Call of the Wild" special car theme sponsored by Hope Contractors. Any car with an animal name; e.g. Firebird, Ram, Barracuda, Mustang, Cobra, Super Bee, etc.
- "Patton Mug" for any US Army/US made tank regardless of whose markings are on them, all sizes/all eras, except dioramas.
- People's Choice Award is sponsored by Bob Hyatt, of Little Rock, AR., and awarded to an entry based on general public's vote. Proxy votes will <u>NOT</u> be allowed, one must be present in order to vote.
- Grand Master's Award Any model that has won the "Best of" award at any level whether local, regional National, or other modeling contest venue.



Directions

From the West: Follow I-20 EAST; Take exit #20B/LA-3 onto BENTON SPUR RD[LA-3] toward BENTON RD; Bear RIGHT to follow LA-3; Arrive at 620 BENTON RD, BOSSIER CITY, on the RIGHT

From the South: Follow I-49 NORTH; Take exit #206 onto I-20 EAST towards MONROE; Take exit #20B/LA-3 onto BENTON SPUR RD[LA-3] toward BENTON RD; Bear RIGHT to follow LA-3; Arrive at 620 BENTON RD, BOSSIER CITY, on the RIGHT

From the North: Follow either US-71 or I-49 SOUTH; From US-71/I49 go EAST on I-220 – go 3.0 mi; Take exit #11 on the LEFT to BENTON RD [LA-3]; Turn LEFT on BENTON RD [LA-3] – go 2.4 miles to BENTON SPUR RD; Turn LEFT on onto BENTON SPUR RD [LA-3] – go 0.2 mi; Arrive at 620 BENTON RD, BOSSIER CITY, on the LEFT

From the East: Follow I-20 WEST; Take exit #20B/LA-3 onto BENTON SPUR RD[LA-3] toward BENTON RD; Bear RIGHT to follow LA-3; Arrive at 620 BENTON RD, BOSSIER CITY, on the RIGHT
